



**GRILL WITH US SWEEPSTAKES
OFFICIAL RULES**

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

The Grill With Us Sweepstakes (the "Sweepstakes") will commence at 12:00:00 AM Pacific ("PT") on May 1, 2021 ("Start Date") and end at 11:59:59 PM PT on September 12, 2021 ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period").

Once entrant has completed the foregoing, he/she will have earned one (1) entry (the “Entry”) into the Sweepstakes. Entry must be received by 11:59:59 PM PT on September 12, 2021 to be eligible for entry into the Sweepstakes.

Website: To enter via the Website, visit <https://www.barefootwine.com/grill-with-us> (“Website”), follow the instructions to complete and submit the website entry. Once entrant has completed the foregoing, he/she will have earned one (1) entry (“Entry”) into the Sweepstakes. Entry must be received by 11:59:59 PM PT on September 12, 2021 to be eligible for entry into the Sweepstakes.

To be eligible, the Entry must be in English. Sponsor or Administrator are not responsible for lost, late, incomplete, tampered or damaged Entries or Entries that are lost or misdirected to any Junk folder or SPAM filter. All such Entries will be ineligible. Entries will not be acknowledged or returned.

4. Winner Notification: Sponsor or Administrator will attempt to notify each potential winner ("Potential Winner") via e-mail or phone on or about September 13, 2021.
