

**Ecco Domani x Brandon Maxwell Designer Label Sweepstakes
Sweepstakes Official Rules**

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

The Ecco Domani x Brandon Maxwell Designer Label Sweepstakes (the "Sweepstakes") will commence at 12:00:00 AM PST (Pacific Standard Time) on August 5, 2020 ("Start Date") and end at 11:59:59 PM PST on August 21, 2020 ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period").

- 1. SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. Gallo Winery, 600 Yosemite Blvd., Modesto, CA 95354 ("Sponsor"). The Sweepstakes is administered by Endeavor, 304 Park Avenue South, New York, NY, 10010 ("Administrator"), for its/Sponsor's Ecco Domani brand ("Brand").

- 2. ELIGIBILITY REQUIREMENTS.** The Sweepstakes is open to legal residents of the United States (excluding Utah) and the District of Columbia who are 21 years of age or older. VOID IN UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW.
